Community & Impact Grant Application Requirements

Not-for-profit organizations that are based on or serve Martha's Vineyard with an Internal Revenue Service 501 (c) (3) status or its equivalent may apply for a grant from the Community Foundation. The programs we support serve Martha's Vineyard and benefit our community.

MVCF Grant Application Criteria

Applications will be judged based on the following criteria:

- Who will be served?
- Project or program is at a stage of development that justifies the requested amount.
- Expected outcomes are clear and realistic.
- The project will have a meaningful level of impact on the quality of life for the residents of Martha's Vineyard.

Please note:

- Awards are made at levels ranging from \$1,000 up to \$25,000. When considering the request level made to the Community Foundation, applicants should gauge the impact of the proposed program in relationship to the dollars requested.
- Martha's Vineyard Community Foundation does not award grant funding for capital campaigns.
- Awards are made for projects, not for general operating support.

Organizations receiving grants from the Community Foundation are required to submit a report on program or project activities within a year of the grant award. The report, which will be submitted online through our portal, consists of a narrative on the outcome of the initiative, a final financial accounting report, and photos that illustrate your project or program. Subsequent requests for support

will not be considered until all reports for prior grants have been received by the Martha's Vineyard Community Foundation.
